As everyone should already know, this year's meet is being held the this Saturday, April 26th. Warm-ups will be at 8:00 am and the meet will begin at 9:00 am.

There are also two days of special "Team Practices" leading up to the meet. The first day is this Thursday, April 24, with the Blue Team practicing from 4:30-5:30 pm and the Green Team from 5:30-6:30 pm. The second day is Friday, April 25, with the schedules reversed and the Green Team practicing from 4:30-5:30 pm and the Blue Team practicing from 5:30-6:30 pm.
