DIRECTIONS TO EMERALD GREENS RECREATION CENTER

TAKE DALE MABRY HWY NORTH TOWARD CARROLLWOOD VILLAGE. YOU WILL GO TWO LIGHTS NORTH OF FLETCHER AVENUE TO NORTH VILLAGE DRIVE (BANK OF AMERICA ON NORTH WEST CORNER) AND TURN LEFT (WEST) ON NORTH VILLAGE DRIVE. YOU WILL FOLLOW NORTH VILLAGE APPROXIMATELY ¼ MILE TO THE SECOND LEFT WHICH WILL BE CLUBHOUSE DRIVE (ALSO THE ENTRANCE TO EMERALD GREENS GOLF RESORT & COUNTRY CLUB). TURN LEFT ON CLUBHOUSE DRIVE AND GO TO FOUR WAY STOP. RECREATION CENTER AND POOL PARKING WILL BE STRAIGHT AHEAD DIRECTLY IN FRONT OF YOU. PLEASE ENTER POOL AREA THROUGH GATES.
